33	Apologies for Absence & Resignations
33.1	The Clerk advised the committee that C Burbage (resigned from committee), C Fenner (resigned from committee). R Strangward (nonattendance) – apologies were accepted.

36.1	<p>Cllr Gasparutti advised the committee that he would like place more dog fouling bins in Turrington / Manton / Artindale in South Bretton.</p> <ul style="list-style-type: none"> • The one by the roadside needs to be repositioned near the left-hand side of the green, south side of Manton. • In Drayton –he needs to examine how many dog bins are there? • Signage– the dog fouling sign is faded and needs to be replaced. • Would like to go and access the areas with other Cllrs to establish what is needed. • Cllr Stanton advised that the dog fouling bin that is located near the dentist in Eyrescroft got removed and never replaced, due to the cabling. – this needs to be investigated.

39	Towns Fund – Update - standing agenda item
39.1	The committee asked if the Clerk could get an update from Cllr Burbage regarding the Towns Fund.
40	Ghost Playground at 102 Sprignall -standing agenda item
40.1	Cllr Gasparutti advised the committee that there were an excessive number of overgrown weeds in the area. The committee asked if the Clerk could get an update from C Burbage in respect of the proposal, he put forward about the project with PECT. Also, the committee advised that they should consulted with the community on what they would like to see / do with the area and suggested that an article could be placed in the gazette asking for ideas. Cllr Gasparutti proposed that he would send the Clerk the article.
41	Youth Provision within Bretton - Update
41.1	The committee advised that there was a youth shelter at Heltwate but that is going to be moved as part of the school development. Yet no one knows where. The Clerk recommended various areas where they could place the youth shelter like near the BMX track or Skate Park. This will give youths somewhere to hang out with their friends. The committee asked the Clerk to contact Peterborough City Council to see if they could advise where a youth shelter can be placed in Bretton.
42	Bulky Waste – Residents Requests
42.1	The Clerk advised the committee that residents are requesting if rubbish can be collected from their homes, as they cannot take them to the specified locations. They have been informed that this is not a service that the Parish Council does. However, they can borrow Cllr Gatward trolley barrow to transport the items or ask a neighbour to assist. Alternatively, they could contact Peterborough City Council as they offer the door-to-door service, but it is chargeable. The Cllrs asked the Clerk to bring this up at the next full Council meeting.

43	To discuss providing Community Education around Recycling	
43.1	<p>The Clerk advised that the Housing Officer from Longhurst Group asked if this item can be added to the agenda for discussion, as they feel that the residents need assistance and guidance on what items can be placed in the bins. The question was asked what they have been doing to eradicate and sort out the problem with recycling.</p> <p>The committee explained that the residents have been complaining on Facebook that that bins / repairs have not been done. Cllr Gasparutti advised that green bins had not been emptied for more than ten weeks, as someone had contaminated them. It was pointed out that if they do not get emptied soon, there would be a problem with maggots.</p> <p>As a cause of action, the committee asked the Clerk to write to Longhurst and request that someone investigate the issue with the bins. Give them seven days to responds, if nothing then escalates it.</p> <p>It was suggested that a map should be obtained for each area to establish what organisation owes what? – Longhurst/ Crosskeys or Peterborough City Council.</p>	
44	Storage of the Glutton Machine & Barrow used by the Lengthsmen - update	
44.1	<p>The Clerk explained the situation with getting a suitable storage place for the barrow, Glutton machine and the material they need each day to carry out their job. The enclosure needs to be secure and have electricity output to charge the glutton machine.</p> <p>The committee reviewed the rooms near the main hall to see if it would be suitable. However, the Clerk pointed out once the centre opens the Glutton and the barrow needs to be housed somewhere else. For temporary measure it was suggested the reception area at the front of the office. The problem with that is the glutton would not fit through the front door.</p> <p>As a course of action, the community asked the Clerk to asked Cllr Strangward for an update on the biking closure he raised at the previous meeting.</p>
